

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.digitaleventpassport.com](http://www.digitaleventpassport.com), and Digital Event Passport LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Digital Event Passport LLC include [www.digitaleventpassport.com](http://www.digitaleventpassport.com). The Digital Event Passport LLC application is an event management application. By using the Digital Event Passport LLC application, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, Digital Event Passport LLC may collect personally identifiable information, such as your:

- First and Last Name
- Business Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Digital Event Passport LLC's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. All such third parties are prohibited from using your personal information except to provide these services to Digital Event Passport LLC, and they are required to maintain the confidentiality of your information.

Digital Event Passport LLC will share the personal information you provide on an event passport with the passport's Event Organizer. Event Organizers may use this information to contact you for, but not limited to, marketing their products and services.

Digital Event Passport LLC may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Digital Event Passport LLC, and they are required to maintain the confidentiality of your information.

### **Right to Deletion**

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

### **Children Under Thirteen**

Digital Event Passport LLC does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this application.

### **E-mail Communications**

From time to time, Digital Event Passport LLC may contact you via email for the purpose of providing announcements, promotional offers, alerts, confirmations, surveys, and/or other general communication. In order to improve our Services, we may receive a notification when you open an email from Digital Event Passport LLC or click on a link therein.

If you would like to stop receiving marketing or promotional communications via email from Digital Event Passport LLC, you may opt out of such communications by clicking on the Unsubscribe button.

### **External Data Storage Sites**

We may store your data on servers provided by third party hosting vendors with whom we have contracted.

### **Changes to this Statement**

Digital Event Passport LLC reserves the right to change this Privacy Policy from time to time. We will notify you about significant changes in the way we treat personal information by sending a notice to the primary email address specified in your account, by placing a prominent notice on our application, and/or by updating any privacy information. Your continued use of the application and/or Services available after such modifications

will constitute your: (a) acknowledgment of the modified Privacy Policy; and (b) agreement to abide and be bound by that Policy.
