During the event, attendees access the Event Passport's unique URL and provide contact information to the organizer in order to access the passport. Attendees check off each square as they complete tasks on the passport. After the event, the event organizer receives a list of all the contact information collected from attendees, along with additional insights about the event's attendance.
